**IMMIGRATION TO CANADA: THE CANADIAN IMMIGRANT INVESTOR PROGRAM**

**The Canadian Immigrant Investor Program seeks to attract experienced business people to invest C\$400,000 into Canada's economy. Investors must:**

- **Show prior business experience;**
- **Legally have accumulated a minimum net worth of C\$800,000; and**
- **Make a C\$400,000 investment in Canada.**

**Your investment is managed by Citizenship and Immigration Canada (CIC) and is guaranteed by the Canadian provinces, which will utilize the capital to create jobs and expand the economy. CIC will return your C\$400,000 investment, without interest, after five years and two months.**

**FINANCING OPTIONS**

There are several financial institutions willing to offer you financing options for your complete or partial investment.

With financing you can meet the investment requirements for the Canadian Immigrant Investor Program.

Our office will offer you various options through different financial institutions to meet your investment needs.

**GENERAL REQUIREMENTS**

To be eligible under the Canadian Immigrant Investor Program, you must:

- Have at least two (2) years of business experience.
- Have a net worth of at least C\$800,000 that was legally obtained, and be willing and able to make an investment of C\$400,000.
- You must also show that you have enough money to support yourself and your dependants after you arrive in Canada.
- Obtain a minimum of 35 points in the Canadian selection grid.
- Meet medical and security requirements. All family members must pass a medical examination and security/criminal checks.

**QUEBEC IMMIGRANT INVESTOR PROGRAM**

Under the *Canada-Quebec Accord*, the province of Quebec operates its own immigrant investor program. All investors in the program must be selected by Quebec and must plan to settle in Quebec.

- Have net assets of at least C\$800,000 acquired through lawful economic activities.
- Have a minimum of three (3) years management experience acquired over the course of the ten (10) years preceding your application for a Québec selection certificate, in a profitable and legal business (agricultural, industrial or commercial), in government or in an international organization.
- The investment of \$C400,000 for a five (5) year term is guaranteed by the Gouvernement du Québec.

At the end of the five (5) year term, the broker or trust company will, within 30 days, reimburse to the applicant the original C\$400,000 investment without interest. However, the amount to be reimbursed may vary if the applicant secured financing for the investment.
